



## Spencer Home Services Giveaway Terms and Conditions

### Overview:

Spencer Home Services ("Sponsor") is hosting two giveaways: the Grocery Gift Card Giveaway and the Annual Vacation Giveaway (collectively, "Giveaways"). By participating, entrants agree to abide by these terms and conditions and the decisions of the Sponsor, which are final and binding.

### Eligibility:

Participants must be legal residents of the United States and at least 18 years of age at the time of entry. Employees, affiliates, and immediate family members of Spencer Home Services are not eligible to participate. The Giveaways are void where prohibited or restricted by law. Participants must live within the Spencer Home Services service area to qualify for both the Grocery Gift Card Giveaway and the Annual Vacation Giveaway.

### How to Enter:

To qualify for both Giveaways, participants must complete ALL of the following:

- Leave Spencer Home Services a Google review.
- Follow Spencer Home Services on Instagram. (spencer\_homeservices)
- Like Spencer Home Services on Facebook.

### Giveaway Periods:

- The **Grocery Gift Card Giveaway** runs weekly throughout 2025, with one \$100 grocery store gift card awarded each week. The winner will be announced every Friday, starting January 10, 2025. Entries must be submitted by 11:59 PM EST on Thursdays each week to qualify for that week's drawing. Winners must pick up their prize at the Spencer Home Services office.
- The **Annual Vacation Giveaway** runs from January 1, 2025, to December 31, 2025. One winner will be randomly selected from all eligible entries and announced in January 2026. The winner will receive a 5-night stay for two in Aruba, with the vacation to take place in 2026.

### Prizes:

- The **Grocery Gift Card Giveaway** offers one \$100 grocery store gift card each week. The specific grocery store is subject to Sponsor's finalization and may vary.

- The **Annual Vacation Giveaway** includes a 5-night stay for two at the Holiday Inn Resort and Casino in Aruba in 2026, with round-trip airfare. Meals and additional expenses are not included. The specific resort, location, and time of the vacation may vary based on availability. Prizes are non-transferable and cannot be substituted or redeemed for cash.

#### **Winner Selection and Notification:**

- For the **Grocery Gift Card Giveaway**, weekly winners will be selected randomly and announced on Spencer Home Services' Facebook page. Winners will also be notified via the email address they used to confirm their entry and must claim their prize within 24 hours. If no response is received, an alternate winner will be selected.
- For the **Annual Vacation Giveaway**, one winner will be randomly selected from all eligible entries at the end of the contest period. The winner will be announced on Spencer Home Services' Facebook page and notified via email. Winners must respond within seven business days to claim their prize. If no response is received, an alternate winner may be selected.

No purchase is necessary to enter or win. A purchase will not increase your chances of winning. Winners are solely responsible for any taxes or fees associated with the acceptance of the prize. All required steps must be completed in order to be eligible for the prize. Incomplete or incorrect entries may be disqualified.
